This Adoption Agreement is entered into on _____ (Date), between the above name Adopter and Lab Rescue OK, Inc.

DEFINITIONS

Fee Schedule/Donation refers to the cost of the Dog being adopted. The fee schedule is as follows:

- Adult Dogs - \$200.00
- Puppies (6 months and younger) - \$225.00
- Senior (7 years and older)/Special Needs dogs - board discretion.

The Adoption Fee Donation is due on the date of adoption and is **non-refundable**.

Waiver of Sterilization means that the Dog being adopted is exempt from being spayed or neutered. Waiver of Sterilization is only an option in Senior Dogs eight years of age or older, and as determined only by a Veterinarian.

Identification Tag means a label made metal or other suitable material that is securely affixed to the Dog's collar. The Identification tag must contain the Dog's name, Owner's Name, Owner's phone number. The Owner's address is also an appropriate addition to an Identification Tag.

Attack Dog Trained means teaching the Dog to be aggressive, violent, destructive, or hostile. Dogs trained in this manner are inherently dangerous and could potentially cause severe injury to persons including children and other animals.

Flea Prevention means continuously protecting the Dog from fleas and ticks. Lab Rescue OK, Inc. recommends Advantix, Frontline, etc. Lab Rescue OK, Inc. does not encourage the use of flea collars as they may cause irritation to the Dog's skin and younger Dogs quickly outgrow them.

Heartworm Prevention means continuously protecting the Dog from the infestation of heartworms. Lab Rescue OK, Inc. recommends monthly prevention products of Interceptor, Heartguard, etc.

Licensing means registering the Dog with: City of Residence
Upon Reading and Understanding each paragraph of this Agreement, initial by each paragraph and sign at the bottom of the Agreement.

TERMS AND CONDITIONS

_____ Lab Rescue OK, Inc. and its' representatives SHALL NOT BE LIABLE for any damage or injury caused by any dog adopted nor does Lab Rescue OK, Inc. make any representations or guarantees as to the dog's Past, Present, or Future medical condition or temperament. There may be information provided about the past history of the Dog, Lab Rescue OK, Inc. shall not be held liable for the accuracy of the Dog's history. Adopter understands that any dog may prone to medical or genetic conditions not readily evident, such as hip dysplasia, eye and/or heart conditions, or any other condition not listed herein and agrees not to hold Lab Rescue OK, Inc. liable for any or all medical or genetic conditions that may arise.

Insurance of Compliance with Contract

_____ The Adopter agrees to allow Lab Rescue OK, Inc. to periodically check on the welfare of the Dog and to ensure compliance with all Agreement provisions. This may include a home visit. Lab Rescue OK, Inc. retains the right to reclaim Dog when neglect, abuse, inadequate home or veterinary care or any breach of this agreement are discovered. Adopter agrees to relinquish the Dog to Lab Rescue OK, Inc. immediately upon request without legal or judicial intervention should such neglect, abuse, or inadequate home or veterinary care is determined at the sole discretion of Lab Rescue OK, Inc.

Inability to Fulfill Contract

_____ Adopter agrees that should adopter for any reason become unable to fulfill this contract or become unable to keep the Dog, the Dog shall be returned to Lab Rescue OK, Inc. Adopter shall not give, or sell the Dog to another party or abandon/relinquish Dog to a shelter. Adopter shall notify Lab Rescue OK, Inc. in writing or via email of inability to fulfill contract and that a return is necessary giving a minimum of 30 days notice.

Maintenance of Dog

_____ Adopter understands that there are costs involved in maintaining Dog and agrees to assume full responsibility for food, health care, licensing, training and all other needs of Dog. Adopter agrees Dog will be kept in a safe environment when left alone and will not be left chained or tied unattended or allowed to run loose or off lead anywhere his safety may be jeopardized. When Dog is outdoors Dog will be provided protection from the elements by a dry insulated draft-free doghouse. Dog is a companion and

must be kept indoors with Adopter when Adopter retires in the evening. Dog shall not be left in the garage or an outside pen.

_____ Adopter agrees to provide quality veterinary care for Dog including, but not limited to an annual distemper/parvo booster, heartworm test and preventative, flea preventative either via pill or other suitable method. Adopter agrees to seek immediate veterinary care when indicated by symptoms or in an emergency. Dog will be neutered or spayed unless written permission to waive sterilization is given by Lab Rescue OK, Inc. Lab Rescue OK, Inc. remains available for consultation and assistance in this and all other areas pertaining to the health and training of Dog. Lab Rescue OK, Inc. is not a veterinary clinic and is not liable for any medical, health, or training advice given.

Dog Tags

_____ Adopter agrees to provide Dog with current license and tags as required by the state and local laws, a rabies tag, and an identification tag. All tags shall be properly affixed to Dog's collar. Dog shall wear his/her collar at all times. Adopter agrees that pinch or other training collars are only to be worn during training.

No Warranties or Representations

_____ Adopter understands that Lab Rescue OK, Inc. makes no warranties, express or implied, and no representations as to the health, fitness, demeanor or well being of Dog. Adopter accepts Dog "As Is". Adopter agrees that Lab Rescue OK, Inc. shall not be responsible if Dog should die after being released to adopter or should bite, scratch, injure, or cause the death of any person or animal or cause damage to property after being released into adopter's custody.

_____ Adopter understands that Dog may carry disease and parasites that may be transmissible to humans. Adopter understands that people with suppressed immune systems are at greatest risk and Adopter holds Lab Rescue OK, Inc. harmless with respect to any damages arising from any disease, injury or illness allegedly caused by Dog.

_____ Lab Rescue OK, Inc. does not warrant the fitness of dog for any special purpose. Adopter agrees that Dog will not be attack-dog trained or allowed to engage in any fighting activity. Dog shall not be used in experiments or research of any kind.

Adoption Donation

_____ The adoption donation specified in this contract shall be paid at the time Dog is adopted. **This donation is non-refundable.**

Choice of Law

_____ Adopter agrees that Oklahoma law shall govern any dispute arising out of this agreement. Adopter further agrees that Tulsa County will have jurisdiction over all disputes arising out of this agreement.

Totality of Agreement

_____ This agreement sets forth all promises, conditions, and understandings between the Adopter and Lab Rescue OK, Inc. If an attorney is employed to enforce this Agreement, Adopter shall pay reasonable attorney fees to Lab Rescue OK, Inc. Adopter agrees that any changes or additions to Agreement shall in the form of an addendum signed by all parties.

_____ If any provision of this Agreement is or becomes void or unenforceable by force or operation of law, all other provisions shall remain valid and enforceable. No verbal assurance that may have been made by any volunteer, veterinarian or foster family is made a part of this Agreement.
